Government of NL Mandatory Vaccination Policy

The Government of Newfoundland and Labrador released the **COVID-19 Vaccine Regulations**, made under the **Public Health Protection and Promotion Act**. The Regulations come into force on December 17, 2021. The Regulations impose different obligations on businesses, facilities, organizations, employees, and self-employed individuals, including members of regulated health professions, and may apply to practise as a Registered Nurse or Nurse Practitioner. Registered Nurses and Nurse Practitioners are encouraged to review the Regulations and be aware of any obligations applicable to them under the [COVID-19 Vaccine Regulations](#)

Changes in Annual Fees

With the decision by CNA to move to individual memberships, the College Council approved the change of the By-laws to reflect this. As a result, **the registration and annual licensure renewal fee for RNs and NPs from the College for April 2022 will be \$73.19 less than years prior.**

Opportunity to join College Council

As a member of the College Council, you will fulfill one of the most important responsibilities of being a registered nurse (RN) – leading your regulatory body in the public’s interest. Why not run for election as a Domain Councillor and/or nominate an RN who can make this valuable contribution to regulation? Scope of Practice Document - Consultation

RN Prescribing

Work has begun on creating the regulations necessary to add prescribing into the scope of RNs in NL. As health care evolves and the needs of the population change, select RNs may have prescriptive authority added to their scope of practice in specific employer identified areas of need.

A New Year...A New CCP

The College is set to unveil a new Continuing Competency Program (CCP) in January 2022. A campaign will be launched at this time to provide all the details on the program with implementation slated for April 1, 2022.

Building Future Relationships

A motion was made at a recent meeting of College Council to explore future relationships with the other health regulators to find ways of greater collaboration, joint ventures and enhanced operational efficiency. Council requested the Executive Director begin preliminary work on the matter.

Changes to Registered Nurses Act - Approval of Auditors

A provincial and national scan showed that nationally most regulators no longer require their membership to approve the appointment of auditors at their Annual General Meetings. Given the process for the selection of auditors and the financial statements themselves are approved by Council and not membership, College Council moved to request that government amend the Act accordingly.

IEN Bridging/ Re - Entry Program's Annual Report

Council accepted the IEN Bridging/ Re - Entry Program's Annual Report which showcased success in preparing students to meet the entry-level competencies and highlighted several achievements and initiatives. An annual report from nursing education programs ensures the program continues to meet the regulatory mandate. The program received a 5-year approved status in October 2019.

FAQs on Immunizations

The College is in the process of creating two new FAQ documents related to immunizations: RNs providing Flu Vaccines in a Community Pharmacy and Provincial COVID-19 Regulations and Mandatory Vaccination requirements. This FAQs will aim to ensure you are aware of regulatory requirements related to these topics. Once finalized, the FAQs will be posted to the website under Practice Topics, Immunizations.
