## **MEETING OF COLLEGE COUNCIL**

The Council of the College of Registered Nurses held a meeting on October 13th, 2022. The following are some of the highlights from that meeting:

### **Approval of Documents:**

#### Medical Assistance in Dying (MAID)

On October 13th, 2022, College Council approved an updated Medical Assistance in Dying (MAID) document that reflects recent Amendments to the Criminal Code of Canada. This document replaces the College's former MAID documents: NPs Providing MAID (2018) and RNs and NPs- Aiding in MAID (2016). #### **Technical Infrastructure Upgrade**

College Council approved the implementation of the Alinity software program.

This program will address the current issues and vulnerabilities in existing systems in the near term, and work to ensure the ongoing integrity and stewardship of membership information in as cost-effective and efficient a manner as possible. As part of this program, a new membership database called Alinity will be implemented in 2023. This will ensure a maximum level of service to the membership, the public and other stakeholders. This initiative will also position the College to be able to participate in an increasing number of inter-jurisdictional and national initiatives aimed at improving regulatory programs and practises in the coming years.

#### Internationally Educated Nurses (IENs)

The College of Registered Nurses has been working closely with the Government of Newfoundland and Labrador to find efficiencies with respect to processing applications from IENs. At the most recent meeting of College Council, a number of initiatives were presented and passed which aim to improve the process. These initiatives have been made effective and will be further detailed by the College in the near future and include:

- IENs who have been granted provisional registration, may now gain currency of practice hours for licensure requirements by successfully completing the College's Supervised Practice Experience Program (SPEP). A link on the website with full details on the program will be coming soon.
  - IENs who meet all other requirements for registration, but their nursing education program was not at the generalist level may be granted an interim licence with restrictions allowing them to practise in a defined area until they complete bridging education for missing content area(s) within provisional registration per

#### **Processing Fee Changes**

In an ongoing effort to be fair to all applicants a review of service fees was conducted with two changes noted here. Council approved a reduction in the processing fees for IENs to align with domestic processing fees and the NP Exam Administration fee to reflect the move to all computer-based testing. These changes went into effect on November 1, 2022.

#### BScN (Collaborative) Program

Council granted a seven-year approved status to the BScN (Collaborative) Program offered through Memorial University of Newfoundland & Labrador at three sites: Memorial University Faculty of Nursing, Western Regional School of Nursing and Centre for Nursing Studies. Annually, the BScN (Collaborative) program's outcome indicators will be reviewed by Council to ensure the program continues to meet an approved status in between the seven-year comprehensive review. Congratulations for an excellent program.

#### **RN Prescribing**

Council approved the RN Prescribing Framework and RN Prescribing Practice Guidelines with the limitations. Further details will be released on this in the near future. Still pending Government Regulations in order to go live.

#### **Strategic Planning Initiative**

Earlier this year the College announced it had commissioned a consultant to work with Council to update the strategic plan of the organization. This is being done in an effort to better reflect the role, mandate, and vision of the College. Council has been very engaged in the progress to date and this work is ongoing.
