NURSYS Canada

Canada's provincial and territorial nursing regulators are embarking on an innovative initiative to bolster verification efficiency for nurses and strengthen public protections for all Canadians. Nursys Canada will be a national database for all nursing regulators to review and exchange information on licensure status.

A safe and secure regulatory tool, Nursys will serve as an added safeguard for the public and ensure nurses who apply to practise in a province or territory are safe to do so.

All nurses in Canada will be assigned a unique identifier which will be consistent across all jurisdictions and will be exclusive to one nurse and one nurse only regardless of where they practise in Canada. Nursys Canada is being built as an effective, efficient, and secure tool for Canadian Nursing Regulators to share registration and disciplinary information so that public protection and trust in nursing are strengthened for years to come.

College Council Highlights

MEETING OF COLLEGE COUNCIL

The Council of the College of Registered Nurses held a meeting on October 17th, 2024. The following are some of the highlights from that meeting:

Paving the Way for Registered Psychiatric Nurses in NL

In anticipation of new legislation that will permit the College to regulate, and license Registered Psychiatric Nurses (RPNs) in Newfoundland and Labrador, the College Council approves the following documents:

- Registered Psychiatric Nurse Entry-Level Competencies (2014)
- Standards of Psychiatric Nursing Practice (2019)
- Code of Ethics (2017)

These foundational documents have been developed and approved by the Registered Psychiatric Nurse Regulators of Canada (RPNRC) and will be essential for RPN licensure, disciplinary, and practice support functions of the College. Once this legislation goes into effect, additional information including the documents listed above will be made publicly available.

Operational Excellence

Council detailed the Strategic Outcomes which have been approved by the Council and identified areas that would be deemed a priority in the coming weeks and months. Council approved these interpretations and granted the College the ability to move forward with the work.

Document Approval

Council approved three practice documents which were developed in consultation with stakeholders. The College thanks the professionals who contributed.
